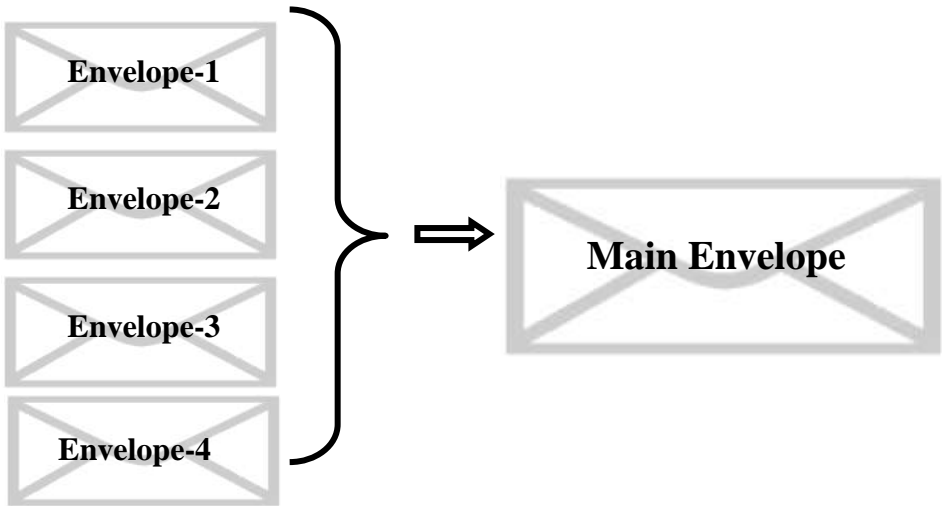

### Terms & Conditions

1.	<b>Tender fees Rs. 1000/- (Non Refundable)</b> for exclusive tender be provided through DD in favour of “ Junagadh Agricultural University Fund A/c ” payable at Junagadh in the Envelope-1.
2.	The <b>EMD (Earnest Money Deposit) will be</b> Rs. 20,000/- in the form of FDR (Refundable) in the name of “Junagadh Agricultural University Fund A/c” payable at Junagadh in the Envelope-1. Quotation without EMD will not be considered. The EMD of disqualified tenderers will be returned within three months.
3.	<b>EMD for each quoted item will be separate</b>
4.	Manufactures must submit <b>certificate of registration as manufacturer</b> in the envelope-2
5.	<b>Authorized dealer / distributor of a company has to submit</b> a copy of their dealership/distributorship certificate validated by the company for the current year along with price bid for each equipment in envelope-3. In case of a chain of dealership (Area dealer sub dealer, local dealer), all the relevant authorization certificates up to the end supplier has to be submitted along with price bid of each equipment in envelope-3.
6.	Indicate the <b>type of currency</b> in price bid (commercial stage) in envelope - 4.
7.	JAU will consider only <b>price bid currency during opening</b> of tender.
8.	Prevailing <b>exchange rate at time of opening of tender will be consider for price comparison</b> and the <b>prevailing exchange rate at the time of work order will be considered</b> in case of foreign currency for successful bidder.
9.	Rates quoted should be <b>inclusive of all applicable Taxes like CST, VAT etc.</b> in envelope - 4.
10.	In case of <b>imported instruments, suppliers will have to clear the consignment; will have to pay custom duty clearance charges.</b> Custom duty exemption documents (Registration with DSIR and other related documents) will be provided.
11.	Should provide <b>two year warranty</b> from the date of installation.
12.	<b>Should make minimum 10 runs (5 samples in duplicates)</b> on site with customer samples and show all the claims made in the catalog without any discrepancy.
13.	The manufacturers shall have to stick to their <b>quality standards</b> while supplying the goods. Goods supplied shall be rejected if found of inferior quality.
14.	On scrutiny of tender documents, any queries raised by the committee have to be replied satisfactorily with all documentary proofs within 7 days.
15.	Installation of equipments will have to be made <b>within 6 weeks of supply.</b>
16.	Installation and demonstration should be given by the company
17.	The vendor has to provide service for the period of two years after the completion of warranty period.
18.	Payment shall be made only after satisfactory installation and demonstration (indigenous equipments).
19.	The <b>list of customers and complete illustrated literature</b> should be enclosed with the tender form in the envelope-3.
20.	Tenderer will have to <b>attach original colour catalog</b> of the each quoted product ensuring exact specifications in the envelope-3.
21.	Post bid scrutiny will be done by instrument committee nominated by the university authority.

22.	Vendor giving wrong information on specification will be <b>black listed for the period of 5 years.</b>
23.	In case of <b>defective items, the same shall have to be replaced by the party concerned</b> at its own cost, and risk, and within stipulated time.
24.	Being an educational institution, we are eligible for exemption of excise duty / custom duty. Hence, rates should be quoted keeping that in mind.
25.	<b>Number of items to be purchased may be varied</b> according to requirement. Tenderer has to sign on all the pages of quoted prices as well as in terms and conditions.
26.	<b>Security deposit @ 2.5% of the work order</b> for the successful tenderer in the form of FDR for 18 month is must before receiving the purchase order.
27.	The instrument/equipment will be <b>purchased within the provision of fund</b> allocated/available.
28.	The purchase of <b>number of instruments/equipments may vary</b> as per the provision of fund during the entire validity period
