Tenders received there after are liable to be rejected.

- 3. The prices quoted must be F.O.R. our site and should be inclusive of all taxes, packaging, forwarding, insurance, commissioning, installation charges etc.
- 4. As an educational institute, we are eligible for the benefit of central excise / custom duty.
- 5. The rates should be valid for six months from last date of receipt of tender.
- 6. The goods will have to be supplied as per the specifications within the prescribed time limit or purchase order, if given.
