The Regulations for the Bachelor of Fisheries Science Degree in the Faculty of Fisheries Science.

REGULATION NO. 1

SHORT TITLE AND COMMENCEMENT:

- 1.1 These Regulations may be called: "The Regulations for the award of Bachelor of Fisheries Science degree i.e., B. F. Sc under semester system in the Faculty of Fisheries Science".
- 1,2 It shall come into force from the Academic year 2008-2009 for the students admitted to B.F.SC. degree course from that year and onwards.
- 1.3 The nomenclature of degree to be awarded under the regulations shall be Bachelor of Fisheries Science (B. F. Sc.) in the Faculty of Fisheries Science as its constituent College of Fisheries located in Junagadh Zone.
- 1.4 The duration of B. F. Sc. degree course shall be 4 years divided into 8 semesters.

REGULATION NO. 2

REQUIREMENTS FOR ADMISSION:

2.1 Following shall be the requirements for admission in the B.F.Sc. degree course. The candidate should have passed Higher Secondary School Certificate Examination in Science Stream with Physics, Chemistry, & Biology and with English as compulsory subject from any statutory University / Board in Gujarat State or Examinations recognized as equivalent there to by the University and should have obtained the minimum requirement of marks at he qualifying examination for admission to the B.F.Sc. degree.

Minimum requirement of marks:

The aggregate marks obtained at the external examination in Science subjects i. e., Physics, Chemistry and Biology in theory Papers only shall be as under:-

(a)	For Scheduled Caste Candidates	35%
(b)	For Scheduled Tribes, Nomadic Tribes	35%
	and Denotified Candidates	
(c)	SEBC Candidates	35%
(d)	For fishermen/fish farmers children	35%
(e)	For all other candidates	40%

- 2.2 Candidates who passed the Central Board of Secondary Education Examination, Delhi from the institutions of Gujarat State in 10+2 pattern with Physics, Chemistry, Biology as the case may be with English and who fulfill the requirement as stated in the regulation in that shall be admitted on basis to the candidates passed from the Gujarat Secondary Education Board with minimum prescribed standard of Admission to the respective faculty.
- 2.3 Weightage of five per cent marks will be given to farmer's sons / brothers / sisters / daughters / grand sons/ grand daughters who are domicile of Gujarat subject to the production of (7 12 & 8A) from the competent authority for having held land in Gujarat under cultivation by himself / herself or his/her father or his/her mother or his/her grand father/ (paternal) or his/her grand mother (paternal) or his/her brother.
- 2.4 Weightage of fifteen per cent marks will be given to fisherman/fish farmer's sons/brothers/sisters/daughters/grand sons/grand daughters who are domicile of Gujarat subject to the production of certificate from the competent authority for having fishing business and fish production by himself or his/her father or his/her mother or his/her grand father or his/her grand mother or his/her brother.
- 2.5 At least 12% seats shall be reserved for fish farmer/ children without any overlapping for double benefits to that effect.
- 2.6 Weight age to the sportsmen/ women for admission will be given as under

- 2.7 The candidates for admission shall be selected on the basis of merit which shall be determined by the scores at the qualifying examination and/or any other test as decided by the University. Those who have passed the qualifying examination with more than two additional trials shall not be considered for admission.
- 2.7.1 The merit order shall be decided on the basis of external evaluation in theory papers of Science subject only viz., Physics, Chemistry and Biology for Higher Secondary Examination. However, while calculating the total number of marks for preparing the merit order list, the marks obtained in the practical in Science subjects shall not be taken into consideration except provided under rules 2.7.2.

- 2.7.2. If, there are candidates who have secured equal number of marks in theory of Science subjects, the merit order shall be determined by application of criteria as under:-
 - (a) For candidates who have secured equal marks their merit order shall be decided on the basis of higher marks obtained in English.
 - (b) Candidates who have secured equal marks in English their merit shall be decided by total aggregate or external marks in theory and practical in science subject.
 - 2.8 The minimum age requirement of a candidate on the Thirty first December of the year of his/ her admission to the degree course shall be 17 years. The above age limit may be relaxed in the exceptional cases by the Registrar.
 - 2.9 The University shall reserve seats for admission of the candidates as specified below provided that nothing in this regulation shall require the University to admit candidates larger in number or with academic and other qualifications lower than these prescribed except in situation as in Regulation No.2.1 above.
- (a) For candidates belonging to the Scheduled Caste, Scheduled Tribe and Socially and Educationally Backward classes of the Gujarat State as may be required by the Gujarat State Government from time to time which at present is as follows

Twenty two per cent of the total seats at the stage of admission shall be reserved for backward classes candidates.

Out of these 22% seats, 7% shall be earmarked for candidates belonging to Scheduled Caste and the remaining 15% shall be earmarked for candidates belonging to Scheduled Tribes, subject to the condition that those who are able to secure admission on merit shall not, however, be counted against the seats for them. Further, it is provided that reciprocal adjustment in the above specified 7% and 15% seats between the two groups will be made, if the need arises on account of vacant seats due to less number of applications in one group and shortage of seats due to more number of applications of eligible candidates in other group. If applications from backward class candidates are more than the reserved seats earmarked for them as above, admission will be given to them strictly on *inter se* merit within each of the two groups.

(b) As required by the Government of Gujarat, 27 % of the total seats shall be reserved for those candidates who fall under the category of Socially and Education Backward communities as defined by the Baxi Commission and Mandal Panch.

A candidate availing him / her self of the reserved seats as above shall be required to produce the certificate of his/ her belonging to a particular group of the backward class from the competent authority of the state.

The candidate belonging to SEBC should produce the certificate showing that he/she does not belong to creamy layer persons or sections, issued during the current year from the competent authority, otherwise he/she will not be considered against the SEBC category.

SEBC candidates, who are able to secure admission on merit shall not however, be counted against the seats reserved for them.

- (c) Fifteen percent extra seats of the total number of seats earmarked `for out state candidates shall be reserved for the candidates nominated by the Government of India/Indian Council of Agricultural Research New Delhi on basis of All India entrance test subject to the conditions that they fulfill the minimum requirement for admission.
- (d) Foreign eligible students seeking admission to B.F.Sc. programme shall have to route their application through their respective embassy at New Delhi or respective Indian missions abroad to the Government of India / ICAR New Delhi and their candidature shall be considered only if they are sponsored by their respective National Government and / or by the Government of India/ ICAR. The candidate will be admitted under reserve quota for ICAR / Government of India sponsored candidates as under rule 2.9(c). However relaxation in eligibility criteria for a foreign student may be granted by the Vice-Chancellor on recommendation of the Government of India/ ICAR New Delhi .Application of a foreign student sponsored by the Foreign Agency who has signed MOU (Memorandum of Understanding) with Junagadh Agricultural University shall be considered as a special case, outside the reserved quota, with or without relaxation in the eligibility criteria by the Vice-Chancellor.
- (e) Three per cent seats are reserved for the disable (Physically handicapped) Candidates as per the conditions statute as under:-

Disable (Physically Handicapped) candidates shall have to fulfill the academic and minimum requirements of marks at the qualifying examination of his/her category as mentioned in 2.1.

" A Candidate having locomoter disability of one leg and partial arm shall be eligible to apply for admission to course, subject to the certificate to that effect from the Civil Surgeon / Medical Superintendent of the Government hospital based on the opinions of the concerned Specialist that the locomoter disabled candidate is in a

- position to undertake the course and perform the functions of the concerned field. The admissions will be on the basis of inter se merit only."
- (f) One additional seat shall be reserved for Parsi Community, Who are domicile of Gujarat State. This seat will be non-transferable.
- (g) Two seats are reserved for Kashmiri migrants as per policy provided as under.
 - 1. Students may be granted following relaxation while giving admission
 - (i) Extension in date of admission by about 30 days.
 - (ii) Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement.
 - (iii) Waiving of domicile requirements.
 - (iv) Facilitation of migration in second and subsequent years.
 - 2. The admission may be considered to such students provided that the nomination is received from Secretary, Agriculture and Co-operation Department, Government of Gujarat.
 - The student shall have to produce certificate from Deputy Commissioner of respective state where he has been migrated from Kashmir along with Registration Number and ration card.
 - 4. This will be applicable till the condition in J & K is normalized.

(h) NRI/PAYMENT SEATS

10 Seats are reserved as NRI / Payment Seats with the conditions stated below.

- (i) The fees for NRI seat will be 3600 US \$ for each semester.
- (ii) The fees on payment seat will be Rs. 28,000/- for each semester plus normal fees.
- (iii) The untitled NRI/ Payment seats will be filled up as payment seats.
- (iv) The candidate seeking on NRI/Payment seat shall have to pay fees for two semesters at the first instance.
- (v) A candidate having passed HSCE or equivalent examination with PCB / PCMB along with English as compulsory subject will be eligible for admission upon NRI / Payment seat.
- (vi) The candidates on NRI / Payment seats will be selected for admission strictly on merit based on the marks obtained by them in the HSCE and they being medically / physically fit and or passed any test as decided as per relevant norms prescribed by the University for Admission to other candidates as stated under regulations. However first preference will be given to the candidate of Gujarat State.
- (vii) The candidate for foreign students shall be considered only if they are sponsored by their respective National Government and or by Government of India / ICAR.
- 2.10 No candidate availing of any of reserved seats shown under 2.9 or enjoying any concessions in admission requirements shall, however, be eligible to get more than one advantage of relaxation in minimum qualification at the same time.

- 2.11 In the event of some or all reserved seats specified under 2.9 (a), (b) & (c) above, remaining vacant due to less number of applications from eligible candidates, they shall be considered as open seats and shall be filled in the order of merit from general list of candidates.
- 2.12 Ten per cent extra candidate may be admitted over the total seats at the stage of admission from the merit list with a view to balance the likely shortfall in the total seats on account of candidates who may leave their studies after paying fees.
- 2.13 The candidates will apply to the Registrar of the University and the admission will be finalized by a committee of the Principal of the College of Fisheries in the University and the Registrar, strictly on merits. The committee will also observe other rules laid down by the University.
- 2.14 Provisionally, admitted candidates called for will be interviewed by the authorities for physical fitness, verification of original mark sheets, certificate, etc. before registration. These candidates shall be required to produce a medical certificate of physical fitness as required by the University from a registered medical practitioner at the time of interview and in case of need they will also be examined by the medical officer of the University.

REGULATION NO. 3

REGISTRATION:

- 3.1 A candidate selected for admission shall become an enrolled student of the University only on completion of his/her first registration in person which consists of the following steps:
 - (i) Payment of fees in person
 - (ii) Submission of original mark sheets and necessary documents
 - (iii) Orientation
 - (iv) Registration for courses.
- 3.2 Selected candidates shall report at the college on the date fixed by the University for their First Registration.
- 3.3 The admission of any candidate who fails to report on the fixed date as in 3.2 above shall be canceled and another candidate on the waiting list may be admitted to the vacant seat, so caused.

It is, however, provided that a candidate who is not in a position to report for the first registration on the date fixed for him/her due to unavoidable circumstances he may obtain provisional registration by paying fees by post or through messenger on or

- before the date fixed for his/her registration. Such a candidate shall be required to complete the remaining steps of registration within one week from the date of commencement of the semester, failing which his/her admission shall stand cancelled.
- 3.4.1 Renewal of registration in the case of continuing students will consist of the following steps to be completed within the first two days of beginning of the semester failing which a fine of Rs. 10 per day of the first seven days and an additional Rs. 20 per day for the next seven days shall have to be paid by the students. After this period the registration shall be cancelled.
 - i. Payment of fees in person.
 - ii. Registration for courses.
- 3.4.2 Late registration only in exceptional cases with fine will be permitted by the Principal for a maximum period of one month only (Fine of Rs.20/- per day for first 7 days and Rs. 40/- per day for next fifteen days) from the date of commencement of the semester after which, the admission of those who failed to get registered will be treated as cancelled except for those whose payment of fees has been guaranteed by either the Government or bonafide institutions or similar bodies.
- 3.4.3 The Principal may at his discretion, however, grant exemption from payment of fine for late registration as permitted under 3.4.2 above only in special cases.
 - 3.5 An under graduate student in faculty may be admitted within a period of three years at his own risk: at the equivalent semester from which he gave up his studies provided that no disciplinary action should have been taken against such student during his career in the college and do not have joined any course / service in other institutes. This period of absence will be calculated from the date he leaves the college. The case of such students needs to be placed before equivalence committee appointed by the Dean/Principal of the college and on the basis of the report of this committee, the revival of registration to the students who gives up the studies will be taken.
 - 3.6 A student enrolled in the University will be given the registration number to be issued along with his name in all the concerned academic documents.
 - 3.7 An identity card shall be issued to every enrolled student. It shall be carried by him and shown when required. In case the identity card is lost a new one shall be issued on payment of the charge fixed by the University from time to time.

REGULATION NO. 4

FEES, DEPOSITS, ETC.

4.1 The fees, deposits, etc., payable by the students of the faculty of Fisheries Science for the B.FSc. degree course shall be as prescribed by the University from time to time.

REGULATION NO. 5

ACADEMIC REQUIREMENTS:

- 5.1 An enrolled candidates, in order to earn his B.F.Sc. degree of the University shall have completed satisfactorily the prescribed number of course credits including those acquired by the approved transfer, 181 credits for B. F.Sc. and shall have earned on overall grade point average (O. G. P. A.) of 5.5 and above.
- 5.2 A course credit means 60 minutes of theory lecture and 2 hours of laboratory/field/plant practical per week through a semester. The course of study include (1) Humanities, Basic Science (2) Core courses in Fisheries (3) Allied fields (4) Internship (5) Electives (6) Study tour and (7) Physical Education/ N. C. C./ N. S. S.
- 5.3. An educational tour of 21 days to South India will have to be undertaken by the students in Eighth Semester as part of the Rural Fisheries Work Experience Programme (RFWEP).

REGULATION NO. 6

SYSTEM OF TEACHING:

6.1 The semester system of teaching and continuous evaluation of a student will be the following: The exact dates of semesters will be announced in an academic calendar prepared by the Principal.

Odd semester July to December

Even semester January to June

Suitable adjustments in these dates will be made to accommodate Diwali holidays which will be notified in the academic calendar. Candidates seeking admission to the First Semester B.F.Sc. degree course will have to apply within one week of declaration of H.S.S.C.E. results and the first semester shall commence within three weeks from the date of the declaration on H.S.S.C.E. results.

6.2 Each student will be assigned to an advisor by the Dean/Associate Dean of the College during the first semester. The advisor will help the student in carrying out The

- Programme of his studies. Students are expected to keep constant touch with their advisors to enable the latter to watch their progress and guide them on right lines.
- 6.3 Grading and evaluation will be in Ten point grade system.
- 6.4 The medium of instruction is English.

REGULATION NO. 7

CURRICULUM AND COURSES:

- 7.1 A student enrolled in the University for the B. F. Sc. degree programme shall be required to pursue the prescribed curriculum and courses as per Regulation No. 5.
- 7.2 The curriculum consists a series of courses designed to provide training to meet the requirements for the award of B. F. Sc. degree.
- 7.3 A course includes lecture and or practical classes and work experience if any in a particular subject covered in a semester.
- 7.4 A student shall be required to earn the credits specialized for the degree programme inclusive of those for physical education, N.C.C./ N.S.S., and study tour, RFWEP etc.
- 7.5 Every semester has a minimum duration of 110 working days, consists of 95 instructional days and 15 Examination days.
- 7.6 In pursuing the course, a student will be required to attend lecture classes and/or to perform practical in laboratory work etc. He / she shall also put required efforts in library work and shall submit the assignments, reports etc. as per instructions from the course teachers. The students who are required to for go classes due to their participation in sports, athletics and other co- curricular activities at inter collegiate, inter University, inter state or National level shall be treated as present for the purpose of assessing their performance by the teachers.
- 7.7 A student shall have to obtain at least 5.0 grade point or above in order to clear a course and to earn overall grade point average (OGPA) of 5.5 to earn the degree.
- 7.8 A student securing less than 5.0 grade point in a course shall be considered to have failed and shall have to clear the same as mentioned in (7.7) above for which only three additional trials shall be given, failing which his/her admission shall stand discontinued.
- 7.9.1 When a student clears a course/courses by more than one trial, the grade points (less than 5.0) obtained by him previously will be replaced by the grade points subsequently obtained by him in the respective course/courses for calculating only the O.G.P.A. for the award of the degree. All the grade points below 5.0 will be considered for calculating C.G.P.A. for determining merit, for the award of scholarship, medals, etc. and grades such as "I" and "US" will be shown in his evaluation report / transcripts.
- 7.9.2 If a student obtain G.P./C.G.P.A. between 5.00 and 5.49 in course/semester, he / she shall be allowed to improve the G.P./C.G.P.A. for not more then three subjects

(Including subjects in which he/she failed) in supplementary examination to be conducted in subsequent semester. While improving the grade point of a subject, only external marks shall be taken in to account for such improvement in G.P./C.G.P.A. and it shall be considered as trial.

- 7.10.1 The minimum percentage of attendance required to be completed by a student in each course shall be 75 % of the total credits hours of the academic calendar in respect of average of theory and practical
- 7.10.2 A condonation up to five per cent may be allowed by the Principal on the recommendation of the concerned teacher / Professor in a special case.
- 7.10.3 A condonation up to 5 per cent may be allowed by the Vice-Chancellor on the recommendation of the Principal of the college concerned. The decision of the Vice-Chancellor shall be final.
- 7.10.4 A student whose attendance in a course falls short of the requirement shall be deemed to have dropped. The final semester end examination of the concerned course/courses and shall be awarded "I" (Incomplete) grade and he will have to repeat the course rejoining the course offered in the next semester.
- 7.10.5 Students, who are required to forgo classes due to their participation in sports, athletics and other co-curricular activities at inter collegiate, inter university, interstate or national level shall be counted as present for the purpose of calculating percentage of attendance.
- 7.10.6 A student admitted to Hospital on account of serious sickness / accident, shall be allowed the benefit of attendance for corresponding number of day depending upon the nature of illness by the concerned Principal of the College as special case only.
- 7.10.7 In case of indoor hospitalization a student whose attendance in a particular course excluding medical benefit, is less than Fifty percent on an average of both theory and practical shall be deemed to have withdrawn the course. He / She will be allowed to appear at the final semester end examination of the concerned course(s) and shall be awarded "W" (Withdrawn) grade and He / She will have to repeat the course by rejoining the course as and when offered in the subsequent semester.

REGULATION NO. 8

SYSTEM OF EVALUATION:

8.1 Mode of evaluation and the weightage to each course shall be as under:

- 8.2.1 The Course Teacher will carry out the internal evaluation through different examinations of theory and practical for each course as the case may be.
- 8.2.2 Paper setting and evaluation of semester end theory examination by the course teacher.
- 8.2.3 Semester end practical examination conducted by the course teacher and the teacher nominated by the H.O.D.
- 8.2.4 The sequence of internal and semester end examination shall be as follows:

(a) Courses having theory and practical:

The sequence shall be first one hour test, internal practical (2 hours duration as the case may be), second one hour test, semester end practical examination (three hours duration) and semester end theory examination (two hours duration).

(b) Courses having theory only:

The sequence shall be first one hour test, second one hour test and semester end theory examination (Two hours duration).

(c) Courses having practical only:

The sequence shall be internal practical examination (two hours duration) and semester end practical examination (three hours duration).

8.3. **EVALUATION SHALL BE MADE AS SHOWN BELOW:**

- 8.3.1 Assignments, periodical tests (the parts of internal assessment) etc. will be during the semester. The number and mode of assignments, periodical test, etc. shall be as determined by the committee of Deans/Associate Deans from time to time.
- 8.3.2(a) A student shall not be permitted to appear at the semester end examination of a Regular course/courses, if the concerned teacher/teachers report that his / her academic performance is not satisfactory and/or that he has not satisfactorily carried out the laboratory work or practicals during the semester and/or he/she has not been regular in attending classes. His / her absence from the semester end examination on this account shall be considered as a trial and he / she will be given "I" grade for that course and will have to repeat that course. He/she will be eligible to take the remaining three trials only after repeating the course/courses as and when they are offered.
- 8.3.2(b) A student shall not be permitted to appear at the semester end examination of a particular semester if he/ she fails to satisfactorily complete his/ her RFWEP and study tour, laboratory work, & practicals etc.
- 8.3.2(c). A student shall not be permitted to appear for the Semester end examination if he/she fails to submit the examination form along with its fees.
 - 8.4 The evaluation made by the teachers/examiner in all examinations of a course shall be recorded as total score/ weighted score and grade points. The following marking shall also be shown by the teachers/examiners/University in the student performance report.

Note: Grade point "S" or "US" shall have no significance in calculating G.P.A./C.G.P.A./O.G.P.A.

- 8.5 A student who fails to appear in any of the examinations (quizzes, test, semester end examination) either in theory and/or in practical shall be marked "Ab" (absent) and the value of "Ab" is to be taken as zero. He/ she shall be given grade/grades in such course/courses with zero value for the absence in the examination in which he/she fails to appear.
- 8.5.1 A student shall not be permitted to appear in the semester end examination of a particular course/courses if he / she fails to appear either in one hourly theory test or in practical test / examination. of internal evaluation.
 - <u>Explanation</u>: Internal evaluation mans one hour theory tests and practical examinations as considered by the Principal of the college.
 - 8.6. There shall be no make up examination for the semester end examination.
 - 8.7. The students obtaining 5.0 or more grade point in a course shall be deemed to have cleared that course and those obtaining less than 5.0 grade point or "W" or "AB" grade shall be required to clear that course subsequently.

It will be obligatory for the students to earn "S" grade for all non- credit courses (Graded as "S" or "US") and RFWEP in order to be eligible for the award of the degree.

8.8 Grade point Average (G. P. A.) is the sum of products of credits of the courses and the respective grade points obtained in these courses divided by the total number of credits of the different courses offered in the semester.

The Cumulative Grade Points Average (C. G. P. A.) is the weighted average of the G. P. A. of all the semester attended, the G. P. A. being weighted by the credit loads of the respective semester.

The Cumulative Grade Point Average obtained at the end of the final semester is the Overall Grade Point Average (O. G. P. A.) of the candidate.

8.9 The award of classes will be based on the O. G. P. A. (Overall Grade Point Average) obtained by the candidates and will be governed by the following criteria.

less than 5.50	Academic Probation	
5.50 - 5.99	Pass class	
6.00 - 6.49	Second class	
6.50 - 7.49	First class	
7.50 and above	First class with distinction	

The class earned by a candidate shall be indicated in his degree certificate.

- 8.10 Verification of the grade awarded will be permissible on payment of a fee as prescribed by the university.
- 8.11 Maximum time limit to obtain degree of B.F.Sc. after first registration is 8 years,

REGULATION NO. 9

CONTINUATION AS AN ENROLLED STUDENT:

Continuation of a student as an enrolled student of the University shall depend on the following conditions:

- (i) Satisfactory academic performance.
- (ii) Satisfactory conduct and disciplined behaviors.
- (iii) Satisfactory conduct of the N. C. C. / N. S. S. or Physical Education,(wherever these are compulsory)
- (iv) Satisfactory health and Physical capacity to continue the academic programme and completion of medical examination, if prescribed.
- (v) Timely payment of University dues/fees.

REGULATION NO. 10

ACADEMIC PROBATION

- 10.1 A student who fails to clear one or more courses in a semester shall be placed on academic probation until he/ she clears the same. Barring withdrawal, non submission of examination form with prescribed fees, absence for any reason from the semester end examination of any course/courses shall be counted as a trial with failure in the said course/courses.
- 10.2 A student on academic probation shall not be promoted to the next semester, if he/she fails in more than four courses offered in the semester.
- 10.3 If a student an academic probation fails to clear only one subject at the second trial, he/she shall be conditionally promoted to next semester to clear that course in make up examination by third trial which is to be conducted within a month of declaration of result, If a student fails to clear such course in make up exam by third trial, he / she

shall not be promoted to that semester for which he / she is conditionally promoted. The student shall be required to clear such course by fourth and the final trial, failing which he / she shall stand discontinuing as an enrolled student of the University.

- 10.4 If a student on academic probation fails to clear more than one courses at the second trial, he/she shall not be promoted to the next semester but may be permitted to register for the semester in the course / courses in which he / she has failed and / or withdrawn to enable him / her to repeat studies of the said course(s) and clear the same at the third trail.
- 10.5 If a student on academic probation fails to clear any course/courses even after third trial, he/ she may be permitted to clear the same at the fourth and the last trial, failing which he/she stand discontinued as an enrolled student of the University.
- 10.6 A student who is not permitted to appear at the semester end examination of a course / courses/ under 8.2.3 (a), shall be required to repeat course/courses by registering in the semester in which those are offered and he/she shall be subsequently permitted to avail of a maximum of three trials to clear the same, failing which he/she shall stand discontinued as an enrolled student of the University.
- 10.7 A candidate who is willing to improve his/ her internal grades by third trial shall be asked to attend theory and practical classes regularly along with regular batch of students. In case of non-satisfactory performance in internal grade improvement, the student be awarded "I" grade.

REGULATION NO. 11

Anti Ragging Committee and Squad are functioning at the University, any one found guilty will be suitably punished, FIR will be lodged against a student(s) abusing fellow student(s)

REGULATION NO. 12 STUDENTS' DISCIPLINE

Student shall abide by any or general rules made by the university and the college authorities in regard to their conduct within the premises of the university and the college and outside. It shall be always presumed that the guardians of the students have agreed that their wards shall comply with the rules. Failure to comply with these rules will make the concerned students liable for disciplinary action as per students' discipline rules as prescribed by the university from time to time.

REGULATION No. 13 ELIGIBILITY FOR DEGREE

A student is deemed to have completed the requirement for graduation and is eligible for the award of B.F.Sc. degree if,

- (a) He / she has satisfied all the rules of evaluation as prescribed by the university.
- (b) He / she has undertaken all the courses as required in each semester and has obtained required grade points in the concerned courses.
- (c) He / she has satisfied the requirements prescribed by the Head of the Departments including RFWEP programme and study tour, if any.
- (d) He / she has paid all fees prescribed by the university.
- (e) There is no case of indiscipline pending against him/her.
- (f) He / she has satisfactorily completed the training of NCC, NSS or physical education wherever necessary.

REGULATION NO. 14 APPLICABILITY

The students admitted during the year 2008 - 2009 and thereafter shall be governed by these rules super ceding all existing rules and regulations governing conduct of B.F.Sc. programme from the day they are approved by the Academic Council. However, the students registered prior to the approval of these rules shall be governed by the rules and regulations in force at the time of their registration.

REGULATION NO. 15 INTERPRETATION

For the interpretation or implementation of any provision of the regulations for conduct of B.FSc. degree programme, the Register of the University may issue necessary orders as and when needed, with prior approval of the Vice-Chancellor.
